AMENDED ORDER GRANTING MOTION TO DETERMINE CONFIDENTIALITY OF COURT RECORDS

THIS MATTER having come on to be heard upon the joint Consent Motion to Determine Confidentiality of Court Records, and each Petitioner having been duly noticed of the motion, and the Court being otherwise advised in the premises thereof, it is hereby:

ORDERED:

- 1. The Motion is GRANTED.
- 2. The confidentiality of the information sought to be sealed is required to protect the following interest under Florida Rule of Judicial Administration 2.420(c)(9):
 - (1) Avoiding substantial injury to a party by the disclosure of matters protected by a common law or privacy right not generally inherent in this type of proceeding.
- 3. The Court further finds that no less restrictive measure is available to protect this interest, and that the degree, duration and manner of confidentiality ordered herein are no broader than necessary to protect the interest.

- 4. Pursuant to Florida Rule of Judicial Administration 2.420(c)(9), Florida Rule of Judicial Administration 2.420(c)(1), and Fourth Judicial Circuit Administrative Order No. 2006-05 "Sealing Court Records," the Clerk or the Circuit Court is hereby ORDERED to seal the entire court file and progress docket in Duval County Case Nos.: 2024-DR-1306 and 2024-DR-1309.
- 5. It is further ORDERED that any materials sealed pursuant to this Order shall be conditionally disclosed upon the Court's entry of a subsequent order finding that such opening is necessary for purposes judicial or governmental accountability or First Amendment rights.
 - (1) That any materials sealed pursuant to this Order may otherwise be disclosed only as follows:
 - i. to any judge of this Circuit for case-related reasons:
 - ii. to the Chief Judge or his or her designee:
 - iii. to adult named parties or their attorneys of record: or
 - iv. by further order of the Court.
- 6. That the Clerk is hereby directed to post a copy of the attached Notice of Entry of Order Authorizing Sealing for a period of thirty (30) days to provide public notice on the "Public Notice Bulletin Board" located in the Clerk's Office, Duval County Courthouse.
- 7. That the Clerk is hereby authorized to unseal any materials seated pursuant to this Order for the purpose of filing, microfiche, imaging files or transmitting a record to an appellate tribunal. The materials shall be re-sealed immediately upon completion of the filing and in accordance with Administrative Order 2006-05.
