**CONSENT ORDER GRANTING JOINT MOTION TO DETERMINE  
CONFIDENTIALITY OF COURT RECORDS**

THIS CAUSE came before the Court based upon parties Joint Motion to Determine Confidentiality of Court Records ("Motion"). The Court, having reviewed the Motion and being informed of the consent of both parties, and having found that the degree, duration, and manner of sealing the documents from public access is no broader than necessary, and there is no less restrictive means, to protect the interests as set forth in Rule 2.420, Florida Rules of Judicial Administration, and being otherwise fully and duly advised in the premises, it is:

**ORDERED:**

1. The Joint Motion to Determine Confidentiality of Court Records is hereby **GRANTED**.

2. The Petition filed by the Petitioner/Husband herein (Doc. No. D2) is determined to be confidential pursuant Rule 2.420, (c)(9)(A)(v), Florida Rules of Judicial Administration, as are any and all record of any hearing on the Motion, or that leads to the entry of this Order, including, but not limited to, electronic records, videotapes, and/or stenographic tapes (as well as the transcript thereof, if transcribed in the future). The foregoing documents shall be referred to as the "Confidential Documents."

3. The Clerk of Courts shall file the foregoing Confidential Documents under seal and/or seal the Confidential Documents, and said Confidential Documents shall be sealed and exempt from public access and shall remain sealed until further Order of this Court.


4. Only the parties and their counsel of record herein shall have the authority to obtain the transcript from any hearing on the Motion or which leads to the entry of this Order. In the event either party wishes to obtain the transcript for any purpose in this case, or otherwise, that party must notify the other party that it is being ordered, and if it is filed in this case, it shall be filed under seal and shall be sealed and exempt from public access and shall remain sealed until further Order of this Court.

5. The names of the parties are not confidential.

6. The Confidential Documents may only be viewed by the Judge presiding over the case, the Respondent/Wife, counsel of record for the Wife, the Petitioner/Husband, and counsel of record for the Husband.


7. Pursuant to Rule 2.420, Florida Rules of Judicial Administration, the Clerk of Court shall post a copy of this Order on the Clerk's website within ten (10) days of the rendition of this Order, and it shall remain posted for 30 days. Within ten (10) days of the rendition of this Order the Clerk of Court shall also post a copy of this Order in a prominent, public location at the Duval County Courthouse, and it shall remain posted for 30 days. After having been posted for 30 days (or on the 31<sup>st</sup> day after the Order has been posted), the Clerk of Court shall remove this Order from its website and from the place where it was posted in the Duval County Courthouse. The Clerk of Court shall also take any and all actions necessary to effectuate each and every provision and term of this Order relative to sealing and keeping sealed the Confidential Documents relative to how those will be listed on the Docket or other Clerk of Court records.


8. This Order shall not be under seal.


