## AGREED ORDER GRANTING UNOPPOSED MOTIONS TO DETERMINE CONFIDENTIALITY OF COURT RECORDS

This cause came before the Court on Plaintiff, Baptist Health System, Inc.'s ("Baptist") Unopposed Motion to Determine Confidentiality of Court Records filed on March 26, 2025 (the "First Motion"), and on Baptist's Unopposed Motion to Determine Confidentiality of Court Records filed on April 8, 2025 (the "Second Motion") and the Court, having reviewed the Unopposed Motion, hereby, **ORDERS** and **ADJUDGES** as follows:

1. The First Motion and Second Motion are **GRANTED**.

- 2. The Court hereby directs the Clerk of Court, that the following components of Plaintiff's Response to Motion for Summary Judgement Vicarious Liability, filed on March 26, 2025, shall be kept confidential and restricted from public access:
  - a. The numerical figures listed in Paragraph 12 of the Response (page numbers 6-7 of the pdf filing);
  - b. Exhibit A (page numbers 30-38 of the pdf filing);
  - c. Exhibit B (page numbers 40-62 of the pdf filing);
  - d. Exhibit C (page numbers 64-289 of the pdf filing);
  - e. Exhibit E (page numbers 296-303 of the pdf filing).
- 3. The Court hereby directs the Clerk of Court, that the following components of Plaintiff's Response to Motion for Summary Judgment as to Unjust Enrichment Claims, filed on April 8, 2025, shall be kept confidential and restricted from public access:
  - a. Exhibit F (page numbers 640-663 of the pdf filing);
  - b. Exhibit G (page numbers 664-890 of the pdf filing).
- 4. In accordance with Rule 2.420(e)(4), the Court makes the following determinations:
  - a. This case is a civil action related to allegations of fraudulent sales of medical devices.
  - b. The grounds for keeping this material confidential are that the Parties have identified them as being trade secret information, and confidential pursuant to the Protective Order and HIPAA Qualified Protective Order regarding disclosure of confidential materials. Ct. Docket #65. As proprietary information, it is further confidential under Florida law and confidential under court rule.
  - c. No party names are determined to be confidential.
  - d. No progress docket or similar records to document activity in the case is determined to be confidential.

- e. The particular information determined to be confidential are the information and exhibits specified in Paragraphs 2 and 3 of this Order, which relate to Stryker sales information and data.
- f. The identification of the persons permitted to view this confidential information filed with the Court, are the Court, court staff, and the Parties.
- g. The Court finds that the (i) degree, duration, and manner of confidentiality ordered by the Court are no broader than necessary to protect the interests set forth in Rule of Judicial Administration 2.420(c), and (ii) no less restrictive measures are available to protect the interests set forth in subdivision (c).
- h. The Clerk of Court is directed to publish this order in accordance with Rule of Judicial Administration 2.420(e)(5).
