**AGREED ORDER GRANTING DEFENDANT'S UNOPPOSED MOTION  
TO DETERMINE CONFIDENTIALITY OF COURT RECORDS**

THIS CAUSE came before the Court on Defendant's Unopposed Motion to Determine Confidentiality of Court Records, filed on January 22, 2026 (the "Motion"). The Court has considered the Motion, been advised that the Parties agree to the entry of this Order without a hearing, and is otherwise fully advised in the premises. The Court, therefore, hereby finds:

**BACKGROUND AND FINDINGS**

1. Defendant seeks to seal the following document pursuant to Fla. R. Jud. Admin 2.420 and 2.425: First Request for Production of Documents to Plaintiff (Dkt. #12) (the "Document").
2. The Document contains confidential and personally identifiable information including social security numbers and dates of birth (specifically Plaintiff's).
3. The Parties have a significant interest in keeping the information contained in the Document confidential.

4. The Parties agree to the entry of this Order to protect the confidentiality of information contained in the Document.

5. The Court deems the Document to be confidential pursuant to Fla. R. Jud. Admin 2.420 and 2.425 because such designation of confidentiality is necessary to avoid substantial injury to Plaintiff and to comply with established public policy respecting privacy set forth in governing Florida and federal law.

6. The Document must be maintained under seal indefinitely, including after the instant case is closed. The Court finds no less restrictive measure is available to protect these interests, and that the degree, duration, and manner of confidentiality ordered herein is no broader than necessary to protect the interests set forth above.

Accordingly, it is therefore **ORDERED** and **ADJUDGED** that:

1. The Motion is **GRANTED**.

2. The Clerk of the Circuit Court shall seal immediately and indefinitely the Document, Docket entry number 12, as requested by the Motion and agreed to by the Parties.

3. The Document may only be disclosed as follows:

(a) To Court personnel.


(b) To the Parties of this Case and their Counsel.
